The Paris City Commission met in a regular session at 9:00 a.m. on Tuesday, January 22, 2019.

Mayor, Johnny Plummer called the meeting to order and the Pledge of Allegiance was recited.

City Clerk, Stephanie Settles conducted roll call.

**Present:** Mayor, Johnny Plummer, Commissioner, Matt Perraut, Commissioner, Commissioner, Wallis Brooks, Commissioner, Stan Galbraith, Commissioner, Anna Allen-Edwards.

**Others in Attendance** City Manager, Daron Jordan, Assistant City Manager, Mike Withrow, City Attorney, Bryan Beauman, and City Clerk/Treasurer, Stephanie Settles.

Upon determining a quorum was present for the transaction of business, City Manager, Daron Jordan proceeded to conduct the meeting.

**Approve Minutes:**

Motion by Galbraith, seconded by Perraut, approving the minutes of January 8, 2019 regular meeting minutes with one correction on how the votes were recorded in the financial section. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, and Brooks, Perraut and Plummer voting Aye.

**Public Comment**

Christie Overman presented information to the Mayor and Commissioners that contained meeting times for cities across the State of Kentucky in relationship to nighttime commission meetings.

Bill Gibson addressed the commission with multiple questions regarding Municipal Order 2018-9.

**New Business**

Mayor, Plummer discussed meeting times and dates; it was agreed by all to review new information submitted by Christie Overman and resume discussion at the next meeting.

Jere Sullivan presented preliminary drawings of renovations to the commissioner's chambers, third floor police department, and to the basement. All agreed to move forward with the next step of the process.

Stacy Chambers provided a transition update with Rumpke trash and recycling services. Rumpke is servicing 3,476 Residential customers, 389 Commercial Customers, and 653 of those customers are recycling which increased by 497 customers. Transfer station savings of \$ 18,170.24 for December, and \$ 10,641.62 January 1 thru 15, 2019.

The new building at Legion Drive is under roof the contractor is working on the doors and trim.

One bid was received for Energy efficiency public performance contracting services, the bid is under review. A recommendation for services will be presented at a future meeting.

A T & T-Mobile/Powertel Contract will be presented for review at the next meeting.

Andy Demoss presented and discussed the draft FY19 budget. The final audit will be presented at a future meeting for approval.

Motion by Allen-Edwards, seconded by Plummer, approving the request from the EMS board to make the purchase of one Auto pulse machine. Motion carried 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

Motion by Perraut, seconded by Galbraith, appointing Earl Hatter to the Paris-Bourbon County E-911 Board. Motion carried 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

Motion by Brooks, seconded by Perraut, approving a Municipal Order leasing City Parks to the Paris-Bourbon County Joint Parks and Recreation Board. Motion carried 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

A MUNICIPAL ORDER CONCERNING AN LEASE OF CITY PARKS TO THE PARIS-BOURBON COUNTY JOINT PARKS AND RECREATION BOARD

WHEREAS, the City joined in an inter-local agreement with Bourbon County to establish a joint parks and recreation board and where such agreement requires the City and County to establish a lease of park grounds with the joint agency to lease real property for recreational use and other public purposes,

NOW THEREFORE be it resolved by the City Commission of the City of Paris, Kentucky that the attached lease for park property including Garrard Park, Chief Reed Park, Claysville Park, Ruckerville Park, Hopewell Springs Park, Thoroughbred Acres Park and the Patrick Brannon Memorial Dog Park is approved and the Mayor is authorized to execute the lease after such time as the joint Parks and Recreation Board has secured insurance under the terms of all agreements.
